## SECTION 5: FIRE-FIGHTING MEASURES

### 5.1. Extinguishing Media

**Suitable Extinguishing Media:** Water spray, fog, alcohol-resistant foam, carbon dioxide (CO<sub>2</sub>), dry chemical powder.
